CLAIM STATEMENT SETUP

The claim is where you state the main topic of your paper. It is a single sentence that tells the reader what you want them to get out of your paper. Throughout the remainder of the paper, the claim is supported by the evidence you provide from your sources.

On page 7 in your packet, you are given the following frame:

Topic: Banned Books

Position: To ban or not to ban

Reasons: separated by commas

EXAMPLE CLAIM STATEMENTS FROM SAMPLE PAPERS

Topic + Position + Reason 1, Reason 2, and Reason 3.

Roll Of Thunder Hear My Cry by Mildred Taylor should be taught in schools because it teaches children and adults that not many African Americans owned land back then, about segregation, and about the past so history doesn't repeat itself.


This book should be taught in schools because it teaches students about the violent past so that history doesn't repeat itself, it teaches student about sharecropping and segregation, and it teaches students about racial inequality.

EXAMPLE CLAIM STATEMENTS

Topic + Position + Reason 1, Reason 2, and Reason 3.


Books in middle schools should be able to be banned because parents should be the ones to decide reading material, banning books protects kids until they are emotionally ready and many challenged books contain sex, drugs, or violence.

Books in middle school should not be banned because schools should follow assigned curriculums, many books that are challenged show social justice issues, and books provide an opportunity for students to understand other people outside of their own experiences.

- An introduction has THREE PARTS.






WHAT IS AN INTRODUCTION?

- An introduction is how you start your essay in one paragraph
- An introduction gives your reader a chance to get to know the subject of your essay
- An introduction has THREE PARTS.
 - Hook
 - Summary of Text/Issue
 - Claim Statement (This Always Goes Last)



HOW DO YOU START AN INTRODUCTION...HOOK!

- Background information that will catch the reader's attention
- An interesting fact about the setting/characters
- An interesting question
- So, Mrs. Hampton ...what's the point?



ATTENTION!

TURN AND TALK. WHY IS IT IMPORTANT FOR YOUR READER TO GET INTERESTED RIGHT AWAY?

WHAT COMES AFTER THE HOOK?

- After you catch reader's attention with the first sentence, use the rest of the paragraph to lead into your CLAIM.
- You do this with a summary of information about your topic.
- This should be general information.
- Double check to make sure it goes with your CLAIM.

EXAMPLE HOOKS


An interesting fact/background information

OR

An interesting question

Where are books being banned in the United States? The answer is in libraries, schools, and in classrooms across the country.

- A CLAIM! You already have submitted a draft to Mrs. H.
- Please follow the given format for your claim statement.
- Make sure to finish with a period and to separate your reasons with commas.
- Did you know? Commas save lives

WHY WE PUT COMMAS IN OUR WRITING...


I like cooking my family and my pets.
